MONTANA FARMERS UNION, hereinafter known as MFU, agrees to lease the Montana Farmers Union, Arrowpeak Camp/Lodge in the Highwood Mountains to the renter for the term indicated above. Unless otherwise agreed to, this Lease covers the entire camp/lodge facilities including the main lodge, recreation hall, handicraft building, cabins, shower building and the girls' and boys' dormitories.

MFU will gladly receive multiple smaller payments toward the final cost. Failure to complete payment by date will cancel reservation and forfeit security deposit.

3. Cancellation Policy

20% Security Deposit is Non-Refundable
80% Refundable if cancellation is more than 2 months prior to the reservation/event
50% Refundable if cancellation is less than 2 months away from reservation/event
0% Refundable if cancellation is less than 1 month away from reservation/event

Renter agrees to pay the amount above for the use of the entire camp/lodge for the dates and times listed above. Renter is required to pay 20% of the entire rental amount at the time the facility is reserved. The balance of the rental fee is due **two months** before arrival.



- 4. **REFUNDABLE CLEANING AND DAMAGE DEPOSIT:** <u>Renter agrees to deposit \$500.00 with MFU a</u> <u>minimum of 14-Days prior to the Renter's arrival.</u> This deposit is held as a cleaning and damage deposit to be applied (if necessary) as MFU deems reasonably necessary at the expiration of this lease. This deposit will provide for cleaning, maintenance and/or repairs of any damage caused by the renter and/or his/her guests of the Arrowpeak Camp/Lodge or other facilities. MFU will determine the amount reasonably necessary to repair any damages caused by the renter and/or his/her guests, and the remainder of the deposit, if any shall be returned to the renter without interest within 14 days after Renter's departure. Renter and MFU agree to do a walk-thru of the facilities upon the arrival of the renter as well as prior to the departure of the renter.
- KITCHEN: As the renter, you are allowed to use the Kitchen. There is no additional charge to use the kitchen. However, it is the responsibility of the renter to fully clean the kitchen and the outdoor BBQ/Grill after its use. The renter must return the kitchen to the same condition it was upon their arrival.
- 6. **ASSIGNMENT OF SUBLEASE:** Renter cannot assign sublet any of its rights under the lease.
- 7. **FACILITY RULES AND REGULATION:** Renter agrees to comply with the list of rules and regulations that are enclosed with this lease and/or posted at Arrowpeak Camp/Lodge. Renter agrees that by signing this rental agreement, he/she is responsible for informing all of the attendees/guests of the rules/regulations and as the renter, he/she is responsible for their actions.
- 8. HOLD HARMLESS: Renter, as well as all guests hereby undertakes to indemnify, defend and hold MFU and its employees harmless from any liability, loss or damage MFU and its employees may suffer as a result of claims, demands, costs, or judgments against it arising from renter's lease of Arrowpeak Camp/Lodge. Montana Farmers Union and its employees shall not be liable for any injury to property or persons on or about Arrowpeak Camp/Lodge.
- 9. **RELEASE FROM LIABILITY:** As the renter and/or responsible party listed on this rental agreement, you hereby agree to and confirm that you will inform all of your guests of the Hold Harmless Agreement listed above (#8), prior to and/or upon arrival to Arrowpeak Camp/Lodge.

By signing this rental agreement, I hereby state and affirm that I have read all of the agreement and I understand its contents and agree to the terms set forth.
